Between July 2017 and June 2018 we continued our work in Rwanda, Africa. In the sectors of Gashora, Mwogo, and Rilima we reached more than 31,082 people with access to clean water. We provided in-depth health and hygiene training and household filter systems to 1,704 families, built and distributed 6 community filters to schools and health clinics, and constructed 13 rainwater harvesting systems on local churches. Our volunteers in Rwanda also visited 1,760 families that have previously received filters to reinforce health & hygiene behaviors and ensure their filters are still working. In the US we utilized 547 volunteers to assemble more than 10,000 filters for use in Rwanda and by partner agencies in over 60 developing countries.
